Christopher Sanders' practice focuses on representing public entity clients in various stages of civil litigation, including in trials, through investigations, and providing general counseling.

Prior to working at Pacifica, Christopher was an Assistant Federal Public Defender for the Western District of Washington. He also worked as an attorney for the King County Department of Public Defense, and with the Pierce County Department of Assigned Counsel. As a seasoned trial attorney, Christopher has experience representing clients charged with misdemeanors and felonies in city, state courts, and federal courts, and has case-management experience at all stages of the litigation process, including pre-trial, trial, and in appellate proceedings.

Before law school, Christopher worked for the United States House of Representatives, Oversight and Government Reform Committee, where he assisted members of Congress and their counsel on investigations on federal and corporate waste, fraud, and abuse. He also assisted on various legislative and governance matters, including advising members of Congress on the passage the American Recovery and Reinvestment Act of 2009, a \$787 billion stimulus bill designed to help the American economy recover from the Great Recession.

In addition to his work as a trial lawyer, Christopher is an active member of the legal community. He was appointed by the Washington State Supreme Court to the Washington State Minority and Justice Commission, where as a commissioner, he is tasked with identifying and addressing problems of race and bias in the state court systems. From 2023 to 2024, he was the Chair of the Washington State Bar Association Disciplinary Board, where he presided over lawyer disciplinary proceedings. Christopher was also proud to serve as President of the Loren Miller Bar Association in 2018, and as Co-Chair of the Charles V. Johnson Youth and Law Forum in 2022 and 2023.
